**MOTION TO TRANSFER CASE**

COMES NOW, Venus A. Jackson, Guardian ad litem for the minor of this case, ask this Court to transfer this case to Family Court's Abuse and Neglect Court for the following reasons:

1. The child has threatened to harm herself if returning home with her Father because of alleged sexual abuse. Said abuse has been hot lined three times, once in Montana and twice here in St. Louis. The minor child has not been evaluated or questioned by the CAC and the Guardian ad litem believes that it is in her best interest that it is done.
2. It has come to the GAL's attention that why in Mother's care the child has tested for Marijuana and Meth.
3. Further the child has even bought marijuana from a person from Snap Chat and there is video evidence obtained from her phone of the child appears to be heavily intoxicated and under the influence. A copy of the text messages is attached and incorporated by reference.

The Guardian ad litem believes that this case needs the attention of the Family Court to one investigate the allegations against Mr. James Judy, to address the neglect and failure to protect the child by Ms. Angela Friener and to provide the minor child with drug treatment in which she is in desperate need at this point.

Wherefore, this Guardian ad litem, Venus A. Jackson, asks this Court to transfer this case to Family Court's abuse and neglect for the best interest of the child and any other orders it deems appropriate.
