Judge Zellweger had received multiple emails from the Defendant in the past. The email address identifies the sender as angelamfreiner@gmail.com. On 3/5/2021 Judge Zellweger received an email from the previously mentioned email address that stated in part "THE COURT DOES NOT HAVE THE RIGHT TO HOLD MY DAUGHTER AGAINST HER WILL OR TRAFFIC HER ACROSS THE COUNTRY! IF SHE IS NOT RETURNED TO ME TODAY THERE WILL BE CONSEQUENCES FOR YOUR CONDUCT. YOU HAVE STEPPED OVER THE LINE FOR ANY TIME OF IMMUNITY AS A JUDGE!" Police went to Defendant's residence to contact her regarding the email. Police knocked on the door, however defendant did not come to the door. Police believe the defendant was present in the residence.
