03/05/2021 Angela was charged with threatening a judicial officer in St Louis MO (21SL-CR00998-01 - ST V ANGELA M FREINER ) & as a result the courts placed an order of protection for the judge in this case (21SL-MC01101 - IN RE THE MATTER OF ANGELA FREINER (E-CASE)) stating the following:

FREINER, ANGELA MICHELLE It is ordered that: 1. Whenever Angela Freiner enters the St. Louis County Courthouse, she shall report to the security staff; 2. The security staff shall escort Angela Freiner to any place in the courthouse where she has legitimate business. The security staff shall only allow her a reasonable time to complete her business and then she shall be escorted out of the courthouse. 3. A copy of this Order shall be mailed to Angela Freiner and given to the security staff. The file and documents shall be maintained by the Circuit Clerk. SO ORDERED: JUDGE MICHAEL D. BURTON

03/08/2021 Angela threatened to come to Phoenix AZ to "fnd me"

Angela was taken into custody later that day/week for threatening a judicial officer (ST MO Case # 21SL-CR00998-01 - ST V ANGELA M FREINER) and when taken into custody she was found to be in possession of a firearm and a packed bag in her car. I believe that if Angela had not been taken into custody she was going to use it to harm either myself or the judge in question.

04/11/2021 Angela posted my address online while accusing me of running a "child sex trafficking ring" on an online forum. This resulted in armed strangers knocking on my door to "investigate" the claims.

As a result of this I have since sold my home & moved in order to protect myself.

05/26/2021 The Attorney in Angela's case was forced to stop representing her because "My family & my life have been threatened & I can no longer represent Defendant zealously under these circumstances" (21SL-CR00998-01 - ST V ANGELA M FREINER)

07/21/2021 Angela sent me my social security number and address in a text message. I took this as a threat to myself.

07/27/2021 Angela has been using my information to "spam" my phone with calls, emails & texts from various companies.

I have received hundreds of calls, texts & emails from individuals asking for Angela to sell her services (IE Vehicle Warranties, Political Organizations, Home refinace & Schools) on my personal phone.

08/01/2021 Angela went onto webcast about "human sex trafficking's" to claim that I kidnaped her daughter and sex trafficked her in hopes of having me harassed by 3rd parties. While also sending me messages stating that the "world will be looking for you" & that the "more her phone rings the more people will know David Judy traffics children"

09/30/2021 Angela has filed several orders of protection against myself and members of my family as a form of harassment. She files the orders (with bogus claims) forcing us (myself, brother, niece and sister in law) to take time off of work, travel to St Louis Missouri (costing hundreds of dollars) to defend ourselves only for her not appear (4 times now). I am in the process of filing a complaint for malicious prosecution in the state of Missouri.

I had a case dismissed this morning for her failure to appear (21SL-PN03226)

09/30/2021 As of this date Angela has several outstanding criminal charges/complaints against her for drugs, guns, fraud & threatening violence in the state of Missouri (case numbers listed below)
